5) No smoking of any kind is permitted in the vehicle. You will be asked once to extinguish your smoking material. If a second request is required, your charter will be terminated. **NO REFUNDS!!!!!!!!!!**

6) A 7 day notice of cancellation is required so you don't incur a cancellation fee.

7) If cancellation is made 9 days prior to event date you will be charged 20% of total cost.

8) If cancellation is made 8 days prior to event date you will be charged 50% of total cost.

9) If cancellation occurs 7 days or less you will be charged the full 5 hour minimum on weekend rentals.
